



## TERMS OF LEASE Baatz Family Farm Crookston, Minnesota

The Baatz Family through Red River Land Company are receiving written bids to enter into a Tenant/Landlord relationship for three years for the following described property located Southeast of Crookston, Minnesota:

### **LENGTH OF LEASE AGREEMENT:** Crop years 2025, 2026 and 2027.

**WRITTEN BIDS:** Bids should be completed on the attached form and submitted to Red River Land Company along with any information regarding your farming operation, financial stability and farming practices you wish to include. Bids are on a per parcel basis.

**PAYMENT TERMS:** All cash rent payments will be payable to the "Baatz Farm Management Agency" and will be due on March 15 of each year. Proposals should be submitted based on dollars per tillable acre.

#### **CONSIDERATIONS:**

- While price will be a significant factor, it will not be the only criteria to award the final rental agreement.
